- Applicants will be assessed according to academic merit and will be in receipt of a government benefit based on financial need or a demonstrated alternative.
- Applications must include documentary evidence of financial need, such as income tested Commonwealth income support payment, such as Youth Allowance, Austudy, ABSTUDY benefits, or other details of financial circumstances.

RULES

BACKGROUND

The Cowan Family Grants / Scholarships are funded by donations received from Bob and Gayle Cowan as trustees of the Cowan Grant Trust. The Cowan Grant Trust was established by Marnie Cowan (Bob's mother) in 1994, who along with her husband Bill believed in the benefits of tertiary education and wanted to help students financially.

RULES

- 1. The Scholarships shall be known as the 'Cowan Family Grant / Scholarships'.
- 2. The Scholarships shall be administered by the Elder Conservatorium of Music (ECM) at the University of Adelaide.
- 3. The annual value and number of scholarships awarded each year shall be at the discretion of the Director of the ECM and shall not exceed the total funds received from the Trustee each year. The number and value of scholarships may not be the same each year. The Conservatorium may award some scholarships early in the year and retain some funds for students in financial difficulty later in the year.
- 4. The Scholarships are intended to provide assistance with education and living costs for a maximum duration of 1 year only.
- 5. To be eligible to apply for a Scholarship, a student:
 - must be able to demonstrate financial need; and
 - must remain enrolled on a full-time basis in any year of undergraduate studies at the Elder Conservatorium.
- 6. Applications must be lodged with the ECM:
 - by 31 March in each year for awarding of the Scholarship in Semester 1 of that year;
 - by 31 August in each year for awarding of the Scholarship in Semester 2 of that year.
- 7. Applications must include documentary evidence of financial need, such as income tested Commonwealth income support payment, such as Youth Allowance, Austudy, ABSTUDY benefits, or other details of financial circumstances.
- 8. Selection of the successful candidate will be made at the discretion of the Director, ECM (and/or nominee) in consultation with the ECM's Scholarships Committee. Preference may be given to regional and rural students.
- 9. The Scholarship must be taken up in the year in which it is offered; acceptance of the scholarship offer cannot be deferred. If a student declines the scholarship offer, the scholarship will be offered to the next eligible student.



- 10. Students in receipt of other major University of Adelaide scholarships may not apply for this Scholarship.
- 11. The scholarship will be terminated where:
 - a student ceases to be enrolled in the approved program of study at the University;
 - a student has provided false or misleading information with regard to their personal details;
 - a student has failed to maintain satisfactory progress for two consecutive semesters;
 - a student is guilty of serious misconduct in terms of the University Policy Rules for Student Conduct in the University.
- 12. The University may vary the rules from time to time in a manner consistent with the University's legal obligations and policies.
