## PROGRAM STRUCTURE

<b>UNITS AND LEVELS</b>	You must complete a total of 108 units of courses, with: <ul style="list-style-type: none"> <li>at least 12 units and no more than 24 units of Level 1 courses</li> </ul>
<b>CORE</b>	You must complete all of the following courses to the value of 12 units: <ul style="list-style-type: none"> <li>a course to the value of 3 units chosen from Arts Core Competency list</li> <li>ARTS 3003 Advanced Humanities: Theory and Method</li> <li>ARTS 3002 Advanced Arts Research Project</li> </ul>
<b>ARTS MAJOR</b>	A major is a sequence of courses in one discipline, totalling 24 units. <ul style="list-style-type: none"> <li>Each major consists of courses at level 1, 2 and 3, and includes a capstone.</li> </ul>
<b>LAW</b>	You must complete Law courses to the value of 66 units. Courses below are a guide only. Please contact the Adelaide Law School for specific advice.
<b>ELECTIVES</b>	You must complete no more than 6 units of Arts elective courses.

## PLEASE NOTE

- A course is usually worth 3 units, with some worth 6, 9 or 12. Information about all courses can be found in Course Planner.
- Some courses have restrictions and/or prerequisites (i.e. other courses you must complete first) - check Course Planner to make sure you meet these, if applicable.
- If you think you might like to undertake an internship or go on exchange, plan early in your degree so you don't miss out.
